

NOTICE UNDER SECTION 33 ROAD TRAFFIC ACT, 1961

I, Christopher Drew Holland, Senior Sergeant First Class of Police, for, and on behalf of the Commissioner of Police, exercise the authority delegated by the Minister of Transport under Section 11 Road Traffic Act, and make the following order under Section 33 of the Act.

I declare that the '2025 Bay to Birdwood' is an event to which this section applies and that the following roads be closed to traffic on Sunday 19 October 2025 between the listed times:

- West Beach Road, West Beach between Military Road and Tapleys Hill Road (event traffic and metro ticket buses permitted)
 Between 6.30 am and Midday
- North East Road, Tea Tree Gully between Perseverance Road and Lower North East Road. (Westbound Carriageway Only)
 Between 7.00am and 1.00pm
- **Church Street, Birdwood** from Warren Road to the National Motor Museum closed to west bound traffic.
- **Wegener Road, Birdwood** from Church Street to Shannon Street, closed to north bound traffic.
 - Between 7.00 am and 3.30 pm.

I direct that persons taking part in '2025 Bay to Birdwood' on West Beach Road be exempted from all Part Eleven Australian Road Rules, Divisions 2, 3, and 4, relating to vehicle position on a road.

I further direct metro ticket busses are exempt from the West Beach Road closure.

TEMPORARY TRAFFIC CONTROL DEVICE NOTICE UNDER SECTION 17 (3) ROAD TRAFFIC ACT, 1961

I further make order under Section 17(3) of the Act that a speed restriction will apply to the following roads on **Sunday 19 October 2025** between the listed times:

25Kmh Speed Restriction:

- Military Road, West Beach for 50 metres either side of West Beach Road
- West Beach Road, West Beach from 50 metres west of Military Road to Tapleys Hill Road

Between 6.30 and midday

- Wakefield Road between Fullarton Road and a point approximately 100 metres west
- Dequetteville Terrace between Kensington Road and Little Angas Street
- **Fullarton Road** between John Street and a point approximately 60 metres south of Watson Avenue
- Kensington Road between Fullarton Road and a point 50 metres east of Charles Street

Between 7.00am and midday

- North East Road, Houghton for 350 metres either side of Lower North East Road
- Lower North East Road, Houghton from North East Road for 50 metres west Between 6.45am and 2.00pm
- **Warren Road, Birdwood** between Torrens Valley Road and a point approximately 200 metres north of Church Street
- Torrens Valley Road, Birdwood between a point approximately 1.3 km east of Warren Road and a point approximately 500 metres west Between 8.00am and 5.45pm

40Kmh Speed Restriction:

- Tapleys Hill Road for 150 metres either side of West Beach Road
- Sir Reginald Ansett Drive from Tapleys Hill Road for 50 metres east
- Tapleys Hill Road from Anzac Highway for 100 metres north
- Anzac Highway between Rose Street and Alison Street (eastbound only)
- **Brighton Road** between Anzac Highway and a point approximately 50 metres south

Between 6.30am and midday

- Anzac Highway from 400 metres south of Greenhill Road to 50 metres north of Greenhill Road (north eastbound only)
 Between 7.00am and 12.00pm
- North East Road from 100 metres south of Tea Tree Plaza/Civic Park intersection to 200 metres north of the intersection (eastbound carriageway only)
 Between 7.00am and 1.00pm

60Kmh Speed Restriction:

 North East Road between Haines Road (Tea Trea Gully) and Victoria Street (Gumeracha)

Between 7.00am and 4.00pm

I also hereby authorise **Altus Traffic Management** or its agents and contractors to install and remove, or cause the installation and removal of necessary and appropriate traffic control devices for the conduct of this event.

I direct that the installation and removal of necessary and appropriate traffic control devices for the conduct of this event can only be performed by a person with work zone traffic management training.

All works to be undertaken must be done so in accordance with the "SA Standards for Workzone Traffic Management" (which calls up the Austroads Guide to Temporary Traffic Management and AS1742.3).

The permit holder must ensure that, a legible and complete copy of this Approval (as either a hard copy or electronic copy) is available at the event site at all times that workers are present and is immediately provided to an Authorised Officer upon request.
